The Embassy of the Republic of Azerbaijan in the Socialist Republic of Vietnam presents its compliments to the Consular Department of the Ministry of Foreign Affairs of the Socialist Republic of Vietnam and in response to the latter's Note No.663/CH-LS-PL dated August 10, 2021, has the honour to inform the following:

In the Republic of Azerbaijan those who are fully vaccinated are entitled to a COVID passport (attached) which are issued either in the form of a vaccination certificate (after receiving two vaccine jabs) or an immune certificate for natural immunity where recovery from COVID-19 is confirmed (attached).

Those who have two doses of vaccine are entitled to a booster dose of vaccine after 6 month since the last vaccine jab and also provided with a vaccination certificate (attached).

The person who has recovered from COVID-19 is entitled to a booster dose of vaccine and provided with a vaccination certificate (attached).

The certificate of vaccination issued in Azerbaijani and English languages. The certificate includes: vaccine type, dose number, injection date, personal information (name, surname, date of birth, passport or personal ID number). The vaccination certificate is issued on the egovernment portal e-gov.az, as well as through the e-Tabib mobile application. Each certificate has a QR code.

The above-mentioned vaccination certificates and the immunity certificates - all are considered COVID-19 passports in Azerbaijan.

In this regard the Embassy of the Republic of Azerbaijan kindly asks the highly esteemed Consular Department of the Ministry of Foreign Affairs to support and facilitate the entry of the Azerbaijani citizens to the country with the Passport/Certificate of COVID-19

The Embassy of the Republic of Azerbaijan avails itself of this opportunity to renew to the Consular Department of the Ministry of Foreign Affairs of the Socialist Republic of Vietnam the assurances of its highest consideration.


