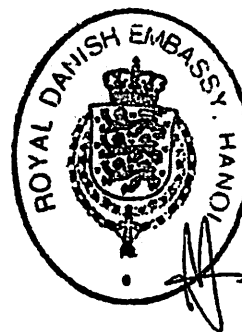
Note Verbale

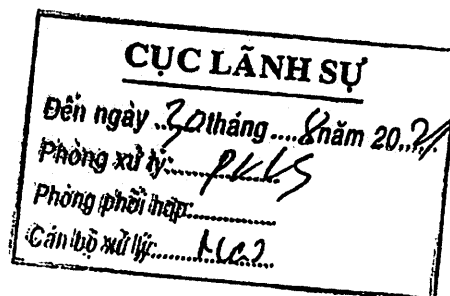

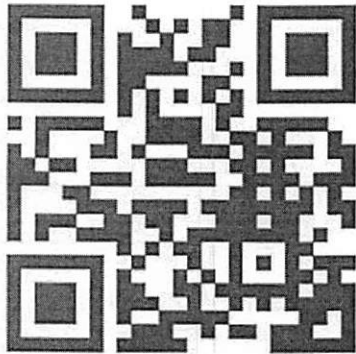
